- This role is responsible for effective and efficient calibrations, ensuring compliance with Novartis quality standards and applicable cGMP regulations.
- Facilitates instrumentation calibration/qualification with external vendors, internal and/or external resources, and local system owners.
- Ensure compliance to cGMP, regulatory regulations, and Novartis global and local policy for equipment.
- Develop/review appropriate SOPs and corresponding forms.
- Responsible for performing all assigned activities within budget and schedule constraints.
- Effectively communicates and collaborates with all levels of the organization.
- Address, assign, and ensure completion of High priority work requests. Ensure activities performed under their supervision comply with all safe work practices and policies.
- Exhibits outstanding problem-solving abilities and completes tasks with precision and accuracy.
- Provide support during audits and inspections.

Shift: This role works Wed-Sat, 10am-8:30pm. This role may require overtime as needed.
