- Lead execution of NPAF strategy with team & develop appropriate communications for stakeholders and customer-facing teams.
- Lead continual gathering and oversight of latest trends in patient assistance programs to identify changes that should be made and to ensure the NVS NPAF is performing well against benchmarked peers.
- Lead execution of Novartis NPAF with service providers and cross-functional stakeholders, demonstrating consistent performance on agreed upon service levels and metrics, managing the budget effectively, and with a long-term plan to improve program sustainability and efficiency
- Lead management of patient escalations with compassion and effective communications.
- Partner with Head, NPAF to ensure appropriate governance is in place to ensure proper execution of NPAF policies and adherence to compliance standards.
- Support advisement of NPAF Board of any reputational or compliance risks associated with NPAF program decisions and execution.
