- Be a point of contact at account & national level for process focused on the new centers activation and ensure enough capacity of each center for RLT treatment
- Work within cross-functional teams to provide capability expertise on center onboarding toolkit and on-site presentations to onboard new centers
- Work within cross-functional teams and with HCPs to identify patient referral pathways between RLT centers and non-RLT centers
- Introduce RLT Care solutions to HCPs and key accounts to optimize patient access and outcomes
- Providing high quality customer service/ excellent customer feedback
- Attention to details/Accuracy ensuring that all reports, data inputs and information provided to internal and external stakeholders are accurate and of high-quality service
