Major accountabilities:

- Lead and define the deployment plan & strategy to maximize the utilization of the NETLab catalog in the community.
- Assist the sites during the NETLab kit deployment and ensure appropriate communication.
- Lead NETLab implementation at new sites/organizations added to the NETLab scope. This includes coordinating the on-boarding activities since preparation to implementation phases including necessary training.
- Monitoring the progress of the Kit Consumption Strategy with adequate metrics and KPIs.
- Provide ongoing life-cycle support for all NETLab endorsed applications, as business owner of the applications.
- Provide support for investigations on technical issues with existing / new kits related to hardware and business.
- Act as NETLab Business System Owner to provide the approval for the application user access review and periodic review.
- Provide detailed technical knowledge of QC/analytical work processes and instrumentation.
- Write, contribute to, and/or review templates, forms, SOPs as required.
- Facilitate cross-platform initiatives to enhance the standardization, harmonization and integration of the business processes supported by the NETLab applications.
- Seeking continuous improvement according to the current and future regulatory requirements and expectations.
- Own the NETLab portal to ensure it is properly updated and maintained.
- Facilitate budget preparation and tracking for NETLab CoE, ensuring requirements are accurately identified and endorsed by all stakeholders according to the target.

- 6 or more years' experience in the pharmaceutical industry Experience in QA Operations or QC, ideally minimum 3 years in QC.
- Thorough knowledge of cGMP requirements

- Technical understanding of laboratory business processes, especially laboratory equipment and systems
- Ideally understanding in IT systems development and deployment
- Team and consensus builder, with definitive and authoritative decision-making ability.
