Key responsibilities:

• Collaborate with the TRD RLT HSE Lead to support HSE programs across TRD IVR, Pilot

Plant, and laboratories, ensuring effective implementation of policies, handbooks, procedures, and work instructions.

- Promote HSE campaigns, conduct periodic walkthroughs, and support general HSE cultural awareness activities.
- Draft, update, and implement HSE and Radiation Safety SOPs, ensuring alignment with internal standards and regulatory requirements.
- Analyze safety and environmental performance, recommend improvement plans, and monitor the implementation of protective measures.
- Assist Radiation Safety activities including instrument periodic controls, environmental surveys, wipe tests, spill/contamination response, waste management, and dosimetry.
- Support emergency handling for hazards such as ionizing radiation and chemicals, coordinating with the TRD RLT HSE Lead.
- Contribute to incident investigation, root cause analysis, and corrective and preventive action implementation.
- Identify HSE risks for employees and third parties, support SAMACO and LOTOTO, and ensure strict adherence to regulatory and internal compliance standards.
