- Collaborate with brand teams, functional teams (e.g., Medical, Patient Services, Market Access, Field, Finance), IDS teams and other NVS partners
- Collaborate with the Business Performance team to optimize data collection and reporting workflows and ensure data integrity and relevance
- Own and manage product backlog for all reporting tools, drive prioritization of enhancements and features in alignment with stakeholders
- Fully leverage GenAl in creation of modern performance reporting interfaces
- Identify and guide teams to streamline and automate data quality processes
