- Ensure appropriate inventory level through purchase orders management and production supply monitoring; Establish and maintain efficient and productive direct communication with counterparts in the production plants; Consulting with product managers to agree demand plan; Material master management in SAP
- Minimize impact of any stock out situations, backorder management and coordination on required sampling for the marketing and TMO department, Coordination of Business Continuity Plan for warehousing and distribution
- Support CZ Supply Chain and Customer Service Manager & Procurement for W&D related projects (tenders, optimizations); support preparation of reports for the regional NTO in Basel
- Execute and support control activities of the NFCM and support Global Trade Compliance policy implementation applicable for local CPO
- Act as Super User for SAP modules MM and SD, and maintains these modules, support department in implementation of new systems (S4Hana, interfaces with 3rd party); support FMD alert tracking process and responsible for reporting process required by local Health Authority (SÚKL)
