- Responsible for the validation and correctness of export authorizations and performs embargo, sanctions, denied party screening to release blocked shipments
- Generate periodic statistics reporting regarding export and import for Corporate functions
- Ensure valid import and export licenses are available for controlled substances at Swiss customs according to the regulations of Swissmedic
- Perform the necessary activities within import and export licenses using the National Drugs Control System (NDS) of Swissmedic
