All scientific exchanges must be scientifically up to date, balanced and of a non-promotional nature. The Senior MSL will also contribute to innovative partnerships and implement relevant disease area strategies. They act as a strategic scientific partner, and collaborate with other Field matrix colleagues (e.g. Commercial, Market Access, HEOR, clinical research colleagues) to ensure Novartis can support healthcare systems to strengthen and improve patient access and outcomes.

- Respond to unsolicited requests for information from stakeholders by sharing appropriate data regarding marketed and pipeline compounds in a timely, compliant, and stakeholder-focused manner.
