- Engage with agency contacts and content owners to follow up on outstanding tasks and resolve queries related to source file uploads and asset rights management.
- Provide support for DAM curation activities including content owner updates, agency updates, task re-assignment, workflow resets, on-demand report scheduling, and assisted search.
- Provide asset migration and bulk upload support to onboard new business units and teams onto the Novartis DAM.
- Partner with the Customer Experience product team to test new feature releases and execute other DAM-related test scenarios.
- Build and maintain subject matter expertise in digital asset management capabilities, workflows, and governance requirements.
- Drive knowledge sharing and people development across the librarian team.
