- Act as the primary point of contact for integration activities across Veeva, middleware or integration platforms, data platforms, and external clinical systems
- Plan and coordinate releases across all environments including development, quality assurance, user acceptance testing, and production
- Manage deployment sequencing, configuration consistency, and regression testing to ensure reliable and predictable releases
- Coordinate release activities across multiple internal teams and external vendors including integration, configuration, and validation partners
- Own integration related risks, assumptions, dependencies, and mitigations, escalating decisions early with clear options and impacts
- Lead cutover planning for integration components including runbooks, rollback strategies, and go live readiness activities
- Review and validate vendor deployment plans, release notes, and supporting documentation
- Serve as the central point of communication for release status, risks, issues, and impacts while driving continuous process improvement

- Release notes, risk assessments, and readiness checklists
