- Drive portfolio-level delivery oversight, including progress tracking, risk management, dependency management, and escalation of critical issues
- Lead the mobilization and oversight of cross-functional program structures (e.g., Tiger Teams) for priority AI initiatives, ensuring delivery at pace and scale
- Oversee resource planning and allocation across the AI portfolio, ensuring optimal deployment of product managers, program leads, and delivery capacity
- Monitor execution performance across AI products and programs, ensuring consistency, predictability, and adherence to defined delivery standards
- Ensure AI products are delivered in a manner that enables and embeds business transformation, including integration into workflows, process changes, and new ways of working, in close collaboration with Line Functions.
