- Manage laboratory materials and equipment, contribute to infrastructure maintenance, evaluate new technologies, and collaborate with cross-functional teams to ensure timely delivery of drug substance (DS) and drug product (DP).

- B.Pharm with 10+ years or M.Pharm with 6+ years of relevant experience in the pharmaceutical industry.
- Proven experience in pharmaceutical formulation development, preferably oral solid dosage forms, with strong knowledge of QbD and biopharmaceutics principles.
- Sound technical expertise in pellet and mini-tablet dosage forms, along with safe handling of chemicals, hazardous materials, and laboratory equipment.
- Working knowledge of laboratory and digital tools, including Electronic Laboratory Notebooks (ELN), with strong collaboration and technical problem-solving skills.
