- Support documentation of data standards, business rules, and data architecture across ingestion, transformation, and aggregation processes
- Ensure alignment with global data governance frameworks and collaborate with internal and technical stakeholders
- Apply enterprise data governance standards across platforms, vendors, and use cases
- Support role-based data access controls aligned with data privacy, compliance, and governance requirements
- Manage data lifecycle governance, including tracking ingestion, transformation, usage, and archival of datasets
- Monitor data quality controls (e.g., completeness, accuracy, timeliness) and support issue resolution
- Act as a coordination and escalation point for data governance issues across stakeholders
- Maintain governance documentation, including data dictionaries, lineage, and usage guidelines
- Support reusability and scalability of datasets while preventing fragmentation across systems
