- Monitor agency compliance with source file and rights management requirements and provide reporting on performance, risks, and improvement opportunities.
- Analyze asset usage rights and licensing information to support content reuse and maximize the value of existing assets.
- Maintain accurate records and documentation to support audit readiness and risk mitigation efforts.
- Partner with Content Enablement teams to identify opportunities for DAM enhancements, process automation, and operational efficiencies.
