MSLs provide deep therapeutic area and product understanding, translate emerging science into meaningful dialogue, and support internal teams with clinical data interpretation. MSL is field-based role and needs to operate primarily in the field, the MSL bridges scientific needs from clinical practice with internal strategy to improve patient outcomes and reinforce Novartis' reputation for scientific excellence.

- Support clinical research by identifying study sites and facilitating collaboration for effective study execution.
- Build strong partnerships with experts, scientific societies, and academic institutions while serving as a trusted scientific resource.
- Ensure all activities comply with regulatory and governance requirements, with accurate documentation and reporting.
